#### INDIANAPOLIS STATEMENT CONCERNING SCRIPTURE

(first draft, August 14, 1994)

We recognize and submit to the autographs (original texts derived inductively from the best extant manuscripts) of all the canonical books of the Old and the New Testaments as a whole, and in all their parts and words (verbal inspiration), as God's only written and authoritative Word, the divinely inspired, revealed, harmonious (without discrepancies or contradictions), and inerrant Word of God (historically accurate in all it reports, including the six days of creation, and prophetically reliable in all that it promises), and joyfully submit to this as the only infallible authority in all matters of doctrine, practice, faith, and life.

Bold print indicates what has been added to the Minneapolis Thesis, Article 1 of 1925.

## FORUM PASTORS AND CONGREGATIONS IN PROTEST

Several FORUM pastors and congregations have felt the need to move into a position of protest with regard to their involvement in the AALC. During the June AALC Convention, opportunities for the convention to make clear statements with regard to the position of the AALC on the Word of God and with regard to the Charismatic issue were all tabled. The FORUM had asked for a clean 'ves' or 'no vote on the Christ Lutheran resolution. When that was not to be, pastors Donald Thorson, Raiph Spears, Roy Steward and John Erickson, as well as the congregations of Christ Lutheran. Chetek, WI, St. Matthew, Indianapolis, IN. and Faith Lutheran, Altoona, PA, all informed the AALC Presiding Pastor that they were in a position of 'suspended participation' with regard to the AALC.

This has meant a suspension of any involvement in any positions of leadership in the church body, and a suspension of all financial support of the AALC by the protesting congregations.

## Where Do We Go From Here?

Following the Conference in Indianapolis, the steering committee of the FORUM met. It was determined then that we would meet for our second conference April 24 and 25, 1995. It was also decided that the steering committee would meet in February to finalize plans for the April Conference.

In order that we might make plans for the future, it was decided that a letter would be sent to the AALC Presiding Pastor indicating that we would request that a preliminary report of the 'Blue Ribbon Committee', authorized by the June Convention, be in our hands in time for our February meeting. This will help us in making decisions relative to the direction we, as member congregations of the FORUM, may wish to take during or following our April Conference.


A mailing will be coming your way following our February meeting with more details as to the content and direction we

We Affirm and hold that The unaltered Augsburg Confession non-negotiables are the central definitive proclamation of the Nature of the Church.

(1) bring about a return to the original understandings which led to the formation of the AALC; and (2) attempt to ensure adherence to the basic principles embodied in the AALC constitution.

We Covenant together to keep in continuous and open communication between ourselves as member Pastors, Boards, and Congregations.
